Remote Working for all staff

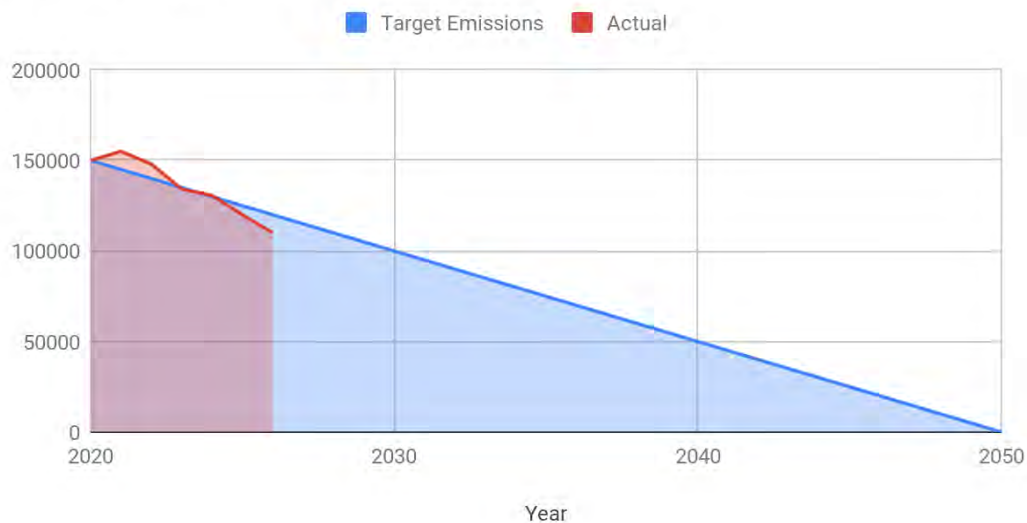
Remote Working for all Associates

We project that carbon emissions will decrease over the next five years to 0.300 tCO₂e by 2026. This is a reduction of 26%

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2021 baseline. The carbon emission reduction achieved by these schemes equate to 0.39 tCO₂e, a 2.5%ge reduction against the 2021 baseline and the measures will be in effect when performing the contract
